- By signing this application, I agree that JDF. has the right to verify any of the information provided herein.
- I agree to abide by the rules, regulations, and policies of JDF while I am volunteering with or fostering for JDF.
- I agree to call and reach a JDF Board member should a foster animal become ill. JDF will provide approved medical treatments and vaccinations for each foster animal.
- I understand and agree that JDF will make the decisions as to the care and adoption of all JDF foster animals. JDF only has the final decision as to whether an animal will be placed in an adoptive home or sent to another facility or adoption center. If a foster decides to adopt a foster animal, an adoption fee will be charged.
- I agree to care for foster animals in my home with love and respect. I agree to ensure that they have food, water, shelter and attention. I will not abuse or neglect any foster animals in my care. If JDF determines that these conditions are not met JDF reserves the right to remove foster animals from my care.
- If I choose to stop/ or dismissed from volunteering or fostering with JDF, I shall promptly return all JDF's property, including any foster animals in my care.
- All foster animals remain the property of JDF. If JDF decides to remove foster animals from my home, I agree that JDF has the right, without further notice or demand, to enter the premises where the animal is housed and remove the animal without process of law. I agree to waive all claims for trespass or damage.
- I hereby grant to JDAR and any other rescue or shelter the right, without fee, to make and use images, likeness, photographs of me and my family in connection with publications of marketing efforts, or any lawful purpose related to that end. I waive the right that I may have to review or approve the finished product, or the use to which it may be applied. I release and discharge JDAR, and any associated shelter or rescue, publisher from liability to be by virtue of any use or publication of any image, likeness or photograph that may occur in the making, publishing, marketing, or selling of the images.
- I recognize that while performing tasks, including handling animals for JDF, there exists a risk of injury or illness to my own or others' animals, me, my family and other persons who come into contact with any JDF animal, as well as risk of personal property loss or damage. I assume the risk of all injuries and property loss or damage in connection with my volunteer activities for JDF.
- I agree that JDF is not liable to me for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer or foster activities for JDF at their adoption facility or any off-site adoption facility (e.g., Petco).
- I hereby release JDF its officers, directors, participants, volunteers and affiliates from any and all claims, actions, liabilities, damages, and costs of any kind arising out of transportation, fostering, or any other work or activity with any animal connected with JDF.
